Old Business:

- a) Request for Council Action - Resolution No. 27 for 2022 - A Resolution Certifying the City Complies with Sections of ORS 475B Related to Marijuana Sales Inside City Limits.

Finance Director Brandon Neish presented Resolution No. 27 for 2022. Resolution No. 23 was passed by the Council, however the ORS references changed during the second legislative session in January of 2022. For accurate record keeping purposes, a new Resolution has been brought forward changing ORS 475 B to ORS 475 C correcting the minor changes in numbering.

New Business:

- a) Downtown Lounge Public Address System Application

Police Chief Jeff Lynn presented the request for a permit for amplified sound during an outdoor event Jamboree Weekend. The planned event has no changes from past events and will be Thursday to Sunday, July 28th to July 31st,

Motion to approve the Public Address System Permit for the Downtown Lounge made by Councilor Richards, Seconded by Councilor Coleman.

- b) Request for Council Action – Resolution No. 20 for 2022 – Fee Schedule
City Manager Pro Tem Christy Wurster introduced the draft fee schedule.

Motion to table Resolution No. 20 for 2022 made by Councilor Coleman, Seconded by Councilor Sanchez.

Mayor Mahler instructed the Council to talk with City Manager Pro Tem Wurster with any comments.

c) Request for Council Action - Proposed Amendments to the Council Rules

City Attorney Snyder explained the proposed amendments from the Administration, Finance, and Property Committee. The Committee felt it was valuable for in person attendance for Executive Sessions. Councilor dress was also discussed and a dress code suggested due to the value of impartiality by not wearing political logos, and to maintain professionalism. Councilor Sanchez stated there are times when a councilor may need to attend meetings directly after work and questioned who determines what "professional attire" is. Councilor Sanchez also questioned if the dress code was applicable during the times when not in a public meeting but still representing the City as an elected official. Councilor Sanchez felt the draft rules were aimed at her after attending a work session in work clothes, however Councilor Coleman clarified the rules had been by the committee discussed prior to the work session in question.

Motion to table the draft rules until clarity can be added and all parties can agree made by Councilor Sanchez, Seconded by Councilor Richards.

d) Request for Council Action - Measure 109 Potential Ballot Measure

Community and Economic Development Director Blair Larsen explained during the November 2022 election, Oregon voters approved Ballot Measure 109 allowing Psilocybin Services. Results of the vote showed Oregon voters were 55% in favor, Linn County voters were 55% against, and Sweet Home voters were 59% against the measure.

Motion to direct staff to draft an ordinance and ballot measure based on the models provided prohibiting Psilocybin service centers and manufactures without a sunset clause made by Councilor Coleman, Seconded by Councilor Richards.

CEDD Larsen asked the Council if they would like to add an additional measure for moratorium, however it was the desire of the Council to keep the ballot as simple as possible and most cost effective.

e) Request for Council Action – Contract for Services – Finance Director Pro Tem

City Manager Pro Tem Christy Wurster reported Finance Director Neish has submitted his official resignation notice to the City. Staff is requesting to bring an interim Finance Director to perform services as outlined in packet. City Manager Pro Tem presented a contract from Matt Brown Consulting for consideration.

Motion to approve the contract for services from Matt Brown Consulting made by Councilor Richards, Seconded by Councilor Trask.

f) Request for Council Action - Resolution No. 28 for 2022 - Extending the City of Sweet Home's Workers' Compensation Coverage to Certain Volunteer Positions

Finance Director Brandon Neish presented the request to extend documentation that shows Workers' Compensation coverage for City volunteers. The annual cost of the coverage was \$100.

Motion to approve Resolution No. 28 for 2022 made by Councilor Coleman, Seconded by Councilor Richards.

Mayor Mahler reported on focus groups hosted by medical students from Western University. Dr. Larry Horton has sent out several dates that Councilors could attend.

City Manager's Report

City Manager Pro Tem Christy Wurster requested the Council complete the LOC Legislative Priorities Ballot and return to staff prior to the next meeting.

The City Manager recruitment update was presented including a schedule of meetings. It was suggested to hold the Community Meet and Greet at City Hall. A question of maximum occupancy was raised. Staff will follow up on the approved occupancy and schedule the meet and greet at City Hall if space allows.

Due to staff changes and timing, City Manager Pro Tem Wurster suggested continuing with the current auditing services one more year. A Request for Proposal (RFP) could be published the following year for auditing services. There were no objections by the City Council.

It was announced the City of Sweet Home won the Favorite Checkpoint for the Annual Cut the Gut Car Cruise. The checkpoint was hosted by Toxic Mopar Car Club. The club members were congratulated for their efforts.


