ORDINANCE BILL NO. 1 FOR 2018

ORDINANCE NO. 1269

AN ORDINANCE ANNEXING TERRITORY WITHIN THE URBAN GROWTH BOUNDARY AND AMENDING THE SWEET HOME ZONING MAP AND DECLARING A NEED FOR AN EXPEDIENCY CLAUSE.

WHEREAS, the Planning Commission of the City of Sweet Home has considered these matters in a public hearing held on March 5, 2018 and continued until March 12, 2018, as provided by law, and has recommended to the City Council that the Annexation and Zoning Map amendment be approved as hereinafter provided; and

WHEREAS, the City Council held a public hearing on this matter on March 13, 2018 and approved these applications by a motion;

Now, Therefore,

THE CITY OF SWEET HOME DOES ORDAIN AS FOLLOWS:

Section 1: The City Council hereby finds that the proposed Annexation: file AX 17-01, and Zoning Map amendment: file ZC 17-01, comply with the applicable decision criteria. The City Council hereby adopts the findings of fact included as Exhibit A.

Section 2: The property within the City of Sweet Home Urban Growth Boundary, Linn County, Oregon, known by Linn County Assessor's Map 14S-1E-6B Tax Lot 700 is hereby annexed into the City of Sweet Home. The subject property is also designated Medium Density Residential (R3) on the Sweet Home Zoning Map as depicted on Exhibit B. The City Limits line shall be expanded to include the subject property. The following legal description corresponds with the Assessor's identifications and describes the subject property:

Real property in the County of Linn, State of Oregon, described as follows:

BEGINNING AT THE NORTH QUARTER CORNER OF SECTION 6, TOWNSHIP 14 SOUTH, RANGE 1 EAST OF THE WILLAMETTE MERIDIAN IN LINN COUNTY, OREGON, RUNNING THENCE SOUTH 89° 58' EAST ALONG THE NORTH LINE OF SAID SECTION 6 A DISTANCE OF 94.0 FEET; THENCE SOUTH 274.55 FEET TO THE NORTHERLY RIGHT OF WAY LINE OF THE OREGON ELECTRIC RAILROAD; THENCE SOUTHWESTERLY AND WESTERLY ALONG SAID RAILROAD LINE TO THE WEST LINE OF THE NORTHEAST QUARTER OF SAID SECTION 6; THENCE NORTHERLY ALONG THE WEST LINE OF THE NORTHEAST QUARTER OF SAID SECTION, 282.4 FEET TO THE PLACE OF BEGINNING.

SAVING AND EXCEPTING THEREFROM THE RIGHT OF WAY OF THE PRESENT COUNTY ROAD ALONG THE NORTH SIDE.

Section 3: Expediency Clause. Whereas there is a possibility of a failed septic system, it is in the best interest of the residents of the City to complete the annexation of the subject property in an expedient manner. It is hereby adjudged and declared that an emergency exists and existing conditions are such that this ordinance is needed to be immediately enforced upon its passage. Therefore, this ordinance shall take effect and be in full force and effect from and after its passage and approval.

Exhibit A to Ordinance Bill No. 1 for 2018 Findings of Fact for Planning Files AX 17-01 and ZC 17-01

Criteria for Annexation Request: AX 17-01

A. Upon receiving any petition for annexation of territory to the city, or before initiating any such action on its own motion, the Council shall refer the proposal for annexation to the Planning Commission for its consideration and recommendation. [SHMC 17.104.010(A)]

<u>Findings</u>: The subject property is located within the City's Urban Growth Boundary (UGB), and annexation would bring the subject property into the City limits. The Planning Commission considered this matter during a public hearing that was opened on March 5, 2018 and continued to March 12, 2018. The Planning Commission recommended approval of the annexation at their March 12, 2018 meeting.

- B. The Planning Commission shall review the proposal for annexation, hold such hearings as it deems proper, make such finding of facts as it deems proper and make recommendations to the Council. [SHMC 17.104.010(B)]
- C. ORS 222.120. Procedure for annexation without election; hearing; ordinance subject to referendum. [Relevant Sections]
 - a. Except when expressly required to do so by the city charter, the legislative body of a city is not required to submit a proposal for annexation of territory to the electors of the city for their approval or rejection. [ORS 222.120(1)]
 - b. When the legislative body of the city elects to dispense with submitting the question of the proposed annexation to the electors of the city, the legislative body of the city shall fix a day for a public hearing before the legislative body at which time the electors of the city may appear and be heard on the question of annexation. [ORS 222.120(2)]
 - c. The city legislative body shall cause notice of the hearing to be published once each week for two successive weeks prior to the day of hearing, in a newspaper of general circulation in the city, and shall cause notices of the hearing to be posted in four public places in the city for a like period. [ORS 222.120(3)]
 - d. After the hearing, the city legislative body may, by an ordinance containing a legal description of the territory in question: [ORS 222.120(4)]
 - i. Declare that the territory is annexed to the city where electors or landowners in the contiguous territory consented in writing to such annexation, as provided in ORS 222.125 or 222.170, prior to the public hearing held under subsection (2) of this section; [ORS 222.120(4)(b)]

<u>Findings</u>: The provisions of SHMC 17.104.010 do not require that this annexation proposal be submitted to the electors of the City for their approval or rejection. The Planning Commission held a public hearing that was opened on March 5, 2018 and continued until March 12, 2018. The Planning Commission made a recommendation of approval to the City Council on March 12, 2018. The City Council held a hearing on this matter on March 13, 2018 at 6:30 PM.

Notice of both public hearings was published in the New Era Newspaper on February 14, 2018; February 28, 2018, and March 7, 2018. Notice of the public hearing was posted in four city locations: City Hall, City Library, Post Office, and the community bulletin board at the northeast corner of 18th Ave and Long Street.

This annexation was approved by the City Council on March 13, 2018, and the City will follow the procedures for adopting an ordinance and providing notification to affected parties as describes in the SHMC and ORS 222.

D. In the event that the Council finds that immediate action is necessary to initiate proceedings for annexation, either before the proposal is referred to the Planning Commission, or before recommendations are received from the Planning Commission, the Council may proceed, but the Planning Commission shall be promptly advised, so that it may have an opportunity to make recommendations to the Council during the Council proceedings. [SHMC 17.104.010(C)]

<u>Findings</u>: The applicant did not request that immediate action be taken under this section. The Planning Commission made a recommendation on this matter at their hearing on March 12, 2018, and their recommendation of approval was conveyed to the City Council at the Council's March 13, 2018 hearing.

- E. When a proposal containing the terms of annexation is approved in the manner provided by the charter of the annexing city or by ORS 222.111 to 222.180 or 222.840 to 222.915, the boundaries of any city may be extended by the annexation of territory that is not within a city and that is contiguous to the city or separated from it only by a public right of way or a stream, bay, lake or other body of water. Such territory may lie either wholly or partially within or without the same county in which the city lies. [ORS 222.111(1)]
- F. A proposal for annexation of territory to a city may be initiated by the legislative body of the city, on its own motion, or by a petition to the legislative body of the city by owners of real property in the territory to be annexed. [ORS 222.111(2)]
- G. A city annexation made in compliance with a comprehensive plan acknowledged pursuant to ORS 197.251(1) or 197.625 shall be considered by the commission to have been made in accordance with the goals unless the acknowledged comprehensive plan and implementing ordinances do not control the annexation. [OAR 660-014-0060]

<u>Findings</u>: The subject property is contiguous to the city limits of Sweet Home to the south and to the north. The north property line borders Alder street, which is within the jurisdiction of Linn County; however, the property across the right-of-way is located within city limits. This is considered contiguous under ORS 222.111(1).

The SHMC does not provide specific criteria for annexations; however, as discussed below, the City of Sweet Home Comprehensive Plan requires that upon annexation that the zoning of the subject property be changed to a City zoning classification that is consistent with the Sweet Home Comprehensive Plan Map. This application for an annexation is therefore linked to the application for a zone change, and staff recommended that these applications be either both approved or both denied. This annexation proceeding was initiated at the request of the property owner.

The Engineering Department provided comments to this application, which are included as Attachment E [Included in the Staff Report Dated February 26, 2018 and located in the record]. The Linn County Planning and Building Department also provided comments, which are included in Section II [of the Staff Report Dated February 26, 2018 and located in the record]. Engineering and Linn County's comments bring attention to the issue of the jurisdiction of Alder Street. The applicant's property does not include Alder Street; however, the extension of City sewer services would most efficiently be provided by extending the existing sewer line in Alder street that is currently located to the east of the property. The sewer line would need to be extended along the full length of the subject property's frontage along Alder Street pursuant to

SHMC 13.08.070. As the annexation is proposed, sewer extension would require work within the Linn County portion of Alder Street, and the applicant would need to obtain a work in the right-of-way permit from Linn County. The Engineering Department recommended annexing the portion of Alder Street that would be affected by the extension.

While it is related to, but outside of the current annexation request, staff agreed that it would be prudent to explore annexing the above mentioned portion of Alder Street. At the same time, it would be advised to consider annexation of 8th Avenue and Old Holley Road; which are both in close proximity to the subject property and located within the Urban Growth Boundary. Staff advised that the right-of-way annexation effort be separated from the project at hand since the City faces a 120-day deadline to make a decision on these applications.

This annexation decision will be made in conformance with the City's acknowledged comprehensive plan; and therefore would comply with the Oregon Statewide Planning Goals pursuant to OAR 660-014-0060.

Criteria for Zone Change Request: ZC 17-01

- H. An amendment to the official zoning or comprehensive plan map may be authorized provided that the proposal satisfied all relevant requirements of this title and also provided that the applicant demonstrates the following:
 - a. The proposed amendment is consistent with the goals and policies of the comprehensive plan; [SHMC 17.12.025(A)]
 - i. Upon annexation, all lands shall be zoned consistently with the Comprehensive Plan and its designations and should be based on public need, special studies or other information which will serve as the factual basis to support the change. [Sweet Home Comprehensive Plan Chapter 2; Land Use Element, Policy 16]
 - ii. Table 1. Summary of Comprehensive Plan Land Use Designations

Land Use Designation	Purpose
Medium Density Residential	To provide areas suitable and desirable for single family homes, duplexes on corner lots, condominiums, town houses, and appropriate community facilities. Densities in this category are slightly higher than those in the low density category.

The Zoning Code implements the Comprehensive Plan by providing specific development guidelines for each Land Use Designation. The general nature of each Comprehensive Plan Land Use Designation will guide the uses and standards for the corresponding zone in the Zoning Code. [Sweet Home Comprehensive Plan Chapter 2; Land Use Element, Portion of Table 1: Summary of Comprehensive Plan Land Use Designations]

<u>Findings</u>: The Comprehensive Plan Map Designation of the subject property is Medium Density Residential. See Attachment B [Included in the Staff Report Dated February 26, 2018 and located in the record]. The goals and polices of the Comprehensive Plan are implemented through the application of zoning that implements the Comprehensive Plan Map designation of the property. The Medium Density Residential (R-3) Zone implements the Medium Density Residential Comprehensive Plan Map designation.

Exhibit A to Ordinance No. 1 for 2018

Based on a review of the Sweet Home Local Wetlands Inventory Map and the National Wetlands Inventory Map, the subject property does not contained inventoried wetlands. As a result, it would not be appropriate to apply the Natural Resources Zone to the property. The subject property is located outside of the 100-year floodplain.

Based on the above findings, the application of the R-3 Zone to the subject property would be consistent with the goals and policies of the Comprehensive Plan. The application complies with this criterion.

b. The proposed amendment is orderly and timely, considering the pattern of development in the area, surrounding land uses, and any changes which may have occurred in the neighborhood or community to warrant the proposed amendment; [SHMC 17.12.025(B)]

<u>Findings</u>: The subject property is located within the City's Urban Growth Boundary, which has been identified as the planned location for urban development in the City. The properties two and three properties to the east were annexed to the Ctiy in 2010 under similar circumstances: they sought connection to the City's sewer system. The subject property is contiguous to the Sweet Home City Limits. For these reasons, the City finds that the application complies with this criterion.

c. Utilities and services can be efficiently provided to serve the proposed uses or other potential uses in the proposed zoning district; and [SHMC 17.12.025(C)]

<u>Findings</u>: The Engineering Department provided comments to this annexation and zone change proposal which are included as Attachment E [Included in the Staff Report Dated February 26, 2018 and located in the record]. The subject property is currently served by City water. The applicant is seeking connection to City sewer. If the applicant seeks connection to the sewer service on Alder Street, they would need to obtain a work in the right-of-way permit from Linn County; until such time as the portion of connecting right-of-way is annexed into the City. Costs associated with the extension of sewer and other services would be the responsibility of the property owner.


The subject property contains approximately 0.52-acre; and if approved, it would be possible to divide the property into lots as small as 4,800 square feet through a future subdivision or partition application process. The applicant has not requested a subdivision or partition at this time. If the applicant seeks to divide the property in the future, approval of those applications may require sidewalk or road improvements as required under the Sweet Home Municipal Code. A host of other development permits may also be required upon future development of the property; however, no specific development has been proposed at this time.

The subject property contains one single-family dwelling; and based on the comments submitted by the Engineering Division; utilities and services could be efficiently provided to the subject property.

d. The proposed amendment to the comprehensive plan map is consistent with Oregon's statewide planning goals. [SHMC 17.12.025(D)]

<u>Findings</u>: This criterion does not apply to a zone change, because the proposal does not require an amendment to the City's Comprehensive Plan Map. The Comprehensive Plan Map designates the subject property as Medium Density Residential, and the applicant is proposing to apply the corresponding Medium Density Residential (R-3) zone. The proposed zoning is consistent with the City's Comprehensive Plan; which has been acknowledged to be consistent with the Statewide Planning Goals.

The tradition of the Capitol Christmas Tree, or "The People's Tree," began in 1964 when Speaker of the U.S. House of Representatives John W. McCormack (D-MA) placed a live Christmas tree on the Capitol lawn. This tree lived three years before succumbing to wind and root damage.

In 1970, the Architect of the Capitol asked the U.S. Forest Service to provide a Christmas tree. Since then, a different national forest has been chosen each year to provide "The People's Tree." The selected national forest also works with partners to provide 75 smaller companion Christmas trees for offices in Washington, D.C.

The last time a tree was selected from Oregon was 2002. It was a Douglas Fir, from the Umpqua National Forest.





Library Advisory Board Minutes March 8, 2018 Meeting time 4:30pm

Present at the meeting were Charlene Adams, Don Hopkins, Diane Gerson and Eva Jurney. Kevin Hill absence was excused. Member of the public present Bonnie Neal.

Motion to approve the minutes as presented for the February 8, 2018 meeting. (Motion approved 4 ayes, 0 opposed.)

The Board reviewed the financial expenditures for the month of February. Rose brought to the Board's attention the magazine subscription renewal payment made to Ebsco on 26 subscriptions for the Library. Rose will ask Brandon Neish about the final percentage from the general ledger of 33.98%. Diane commented that she is amazed that we added 36 new patrons in the month of February. The Board reviewed the circulation statistics.

The Board reviewed the Pacific Power bills from 2012 to 2018. The Board had asked for a printout to look at the impact of the light retrofit in November, 2013 and the installation of the exterior lights in June, 2016. On average, the monthly bill is \$600. The retrofit did not represent significant savings and the additional exterior lights did not seem to add to the monthly bills. Don inquired about the overall cost of the retrofit. The lights needed to be retrofitted because the original lamps and ballasts were no longer being manufactured.

The Library will be having a program on Tuesday, March 20 at 4pm called Explosions, Inc. Included in the Board packets were descriptions of the summer reading programs. Rose explained that Traveling Lantern on August 1st had to cancel and we will be scheduling another program. Don asked how the programs were selected. Rose explained that, when possible, the summer reading programs are scheduled with Albany Public to save travel cost. The programs will be at the Boys and Girls Club.

A letter of intent is being submitted to the Collins Foundation to assist in paying for the summer reading programs. In April, a grant will be submitted to Dollar General to purchase high interest / low reading level books and graphic novels. These books will help struggling readers.

Rose reported that Directors from libraries around the state will be meeting March 9th. On Tuesday, March 13th the Linn Libraries Directors will be meeting to discuss sharing DVDs and courier costs for the next fiscal year. On March 21st we will be meeting with the summer reading volunteers, Miriam Swanson from the New Era, Tyler Reese from the Boys and Girls Club to review the upcoming summer reading programs. Also on March 21st, we will be hosting Crawfordsville HeadStart for a family night in the Library. During spring break, we will be painting rocks and making ornaments for the Capital Christmas tree.

Rose asked if Bonnie Neal if there were any questions she wanted to ask the Board members. Bonnie responded that she normally works and is unable to attend the meetings but that she had the day off. She said that she supports libraries.

Rose invited the Board members to check out the new dollhouse in the Children's area.

The Planning Commission considered code amendments to implement Senate Bill 1051 at their meeting on April 2, 2018. Senate Bill 1051 takes effect on July 1, 2018 and requires that the City allow: "the development of at least one accessory dwelling unit for each detached single-

family dwelling, subject to reasonable local regulations relating to siting and design." The City may adopt "clear and objective" standards that would apply to accessory dwellings. These standards may include parking requirements, height restrictions, and other non-discretionary standards. SB 1051 also defines uses that may be established as a part of church use, and establishes the requirement to process certain affordable housing project applications within 100 days rather than the current 120-day rule. I anticipate that these code updates will be brought before the Planning Commission and the City Council at public hearings in May. This should allow time to adopt changes to our code by July 1, 2018.

Projects and Activities:

Staff provided support to the Planning Commission at their meetings on March 5, 2018, March 12, 2018 and March 19, 2018. Staff also provided support to the Park and Tree Committee Meeting at their meeting on March 21, 2018.

3. ECONOMIC DEVELOPMENT

I attended the Sweet Home Active Revitalization Effort (SHARE) meeting on March 14, 2018. The City Council discussed the draft Economic Development Strategy at the March 27, 2018 meeting, and staff will now move forward to create a commercial exterior improvement program and possibly a gap financing loan program. We will update the City Council as these projects progress.

4. PARKS - RECREATION PROGRAMMING

CEDD staff are currently coordinating with the Public Works Department and the Park and Tree Committee on moving forward with development projects at Sankey Park. We will create a project page soon on the City website in order to keep the public apprised of projects that are scheduled to occur at the Park.

Testimony, arguments and evidence must be directed toward the criteria described or other criteria in the plan or land use regulation which the person believes to apply to the decision. Failure to raise an issue accompanied by statements or evidence sufficient to afford the decision maker and the parties an opportunity to respond to the issue precludes appeal to the Land Use Board of Appeals based on that issue.

Chairperson Gatchell stated the first public hearing will be in regards to;

APPLICATION CU 18-05: The applicant is requesting a conditional use permit in order to establish a church on a property zoned Commercial Highway (C-2). The subject property contains approximately 1.1 acres. The applicant is Tom Grenz, and the property owner is Full Gospel Church of Sweet Home. The property is located at: 2331 Main Street, Sweet Home, OR 97386; and identified on the Linn County Assessor's Map as 13S01E32BA Tax Lot 1800 and 13S01E32BD Tax Lot 104. They explained that no one will be residing in the structure.

As the above statistics show our calls for service have increased through the first quarter of this year compared to the same time frame in 2017. We are keeping a close watch on these calls to see if we can detect a specific pattern that we may be able to effectively address.

After 5 weeks of training, on April 3rd, Officer McDonald and K9 Gemma passed their Oregon drug detection certification test. Gemma is now a certified three odor drug detection K-9 which enables her to detect methamphetamine, cocaine and heroin. Gemma will be fully deployed and on-duty during the second week of April. We are really excited about the opportunities that both Gemma and Officer McDonald will bring to us.

April is considered Child Abuse Awareness month and will consist of several events around the County that are designed to raise awareness. Our event is planned for April 7th at 11:00 am.

During the first quarter of 2018, the Sweet Home Police Department has received or investigated over 88 reports of abuse or concerns regarding the welfare of children. These reports have ranged from information reports, to welfare checks, to physical abuse and sexual abuse investigations.

PROJECT: Relocation of Engineering Office

SCOPE: Relocate Engineering to 24th Ave Maintenance; scan vital historic records. **STATUS:** Office relocation is complete. Scanning of vital historic records into digital is substantially complete.

PROJECT: Wastewater Treatment Plant Facility Plan Phase 1

Scope: Upgrades to equipment & processes for DEQ Compliance

STATUS: Project kickoff meeting with MurraySmith is scheduled this month.

PROJECT: DEQ - 18th Ave groundwater contamination resolution

Scope: Support DEQ project to resolve neighborhood issue of contaminated

groundwater east of 18th Ave and north of Tamarack St.

STATUS: Project is in predesign by 3rd party.

PROJECT: Air/Vacuum Valve Program

Scope: Locate air/vacuum relief valves on city water system and prioritize recommended maintenance, to resolve distribution issues caused by air pockets.

STATUS: Initial inventory survey is complete. Priority repairs and new installations are

underway.

PROJECT: Water Service Reconnection Program

Scope: On streets with redundant water mains, reconnect water services from old 2" mains to existing new larger mains and abandon redundant 2" mains.

STATUS: Plans for Elm St service reconnections complete. Ready for bid pending

funding.

PROJECT: Bus Shelters (collaboration w/Linn Shuttle)

Scope: Support Linn Shuttle grant project to install bus shelters at highway locations. **Status:** Locations of shelters have been refined & checked for basic construction obstacles/needs (underground utilities, extent of work per location, etc). Linn Shuttle is finding a contractor to install shelters.

PROJECT: 10th Ave Reservoir Leak & SCADA Relocation

Scope: Resolve water loss issue from leaking 1938 reservoir and relocate SCADA equipment to newer reservoir.

STATUS: The original reservoir has substantial leaks. PW Maintenance is working to isolate the tank & quantify the leak rate. The SCADA contractor is preparing a quote for relocating equipment onto the newest reservoir on 10th Ave which will provide better level data at low storage levels and allow continuance of data connection while the old reservoir is isolated/evaluated.
