PURPOSE OF THIS RCA:

The purpose of this RCA is to request direction from the City Council on how to proceed with respect to re-designation of the Sweet Home Enterprise Zone.

BACKGROUND/CONTEXT:

The City of Sweet Home Enterprise Zone expires June 30, 2018. The City may re-designate the Enterprise Zone, and is not bound by the current boundaries of the existing enterprise zone. The existing enterprise zone includes properties that are located outside of the Sweet Home City Limits. If the City chooses to not include the properties outside of City limits in the renewed enterprise zone, then those properties could be included in a Linn County enterprise zone.

Business Oregon describes the standard enterprise zone exemption as follows:

Hundreds of diverse companies throughout the state have enjoyed this program's immediate cash savings on new investments in an enterprise zone:

- Manufacturing, processing, storage, distribution, service centers, and corporate headquarters are all eligible, pursuant to a local authorization application before hiring or any construction or installation begins.
- New buildings, additions, and equipment installed on site receive 100% property tax abatement if zone employment rises by the greater of one job or 10%.
- Exemption is for a minimum of three years after the year in which the qualified property is placed in service.
- The local zone sponsor may extend the period of tax abatement up to five consecutive years, in total, by entering into an agreement which may have additional conditions, and, except in Salem or Portland-area urban zones, if average wages and compensation of new employees meet certain criteria relative to county average wages.

In summary, an enterprise zone provides a tax incentive for businesses that invest in qualifying projects. The overall objective is to increase employment and economic activity within the region.

THE CHALLENGE/PROBLEM:

The questions before the City Council are:

1. Should the City re-designate the Sweet Home Enterprise Zone; and

2. If the City re-designates the Enterprise Zone, should it also include the properties that are currently within the Zone but outside of City limits?

If the City Council directs staff to proceed with re-designation of the Sweet Home Enterprise Zone, staff will seek consultation from all affected taxing districts at a required public meeting. Staff will then bring a resolution before the City Council to designate the Enterprise Zone.

STAKEHOLDERS:

- <u>City of Sweet Home Residents</u>. Residents may benefit from additional job opportunities that are created from development within the Enterprise Zone. Alternatively, the Enterprise Zone may provide tax abatement to projects that would have been completed without the availability of tax abatement. This may decrease tax revenues that are available for the provision of City services.
- <u>Business Owners</u>. Business owners with qualifying projects may benefit from the tax abatement that comes with qualifying development in an Enterprise Zone.
- <u>Taxing Districts</u>. Taxing districts may forgo revenue from development projects that would have been completed without the designation of the Enterprise Zone.
- <u>Staff</u>. Staff would have the responsibility to complete the administrative duties that are associated with managing the Enterprise Zone.

ISSUES & FINANCIAL IMPACTS:

 Financial Impacts: An enterprise zone provides tax abatement as an incentive for certain development and job creation. It is possible that the City and other taxing districts may forgo tax revenue that would otherwise be received during the period of abatement (3-5 years). This financial impact can be difficult to gauge since a particular development may not have occurred without the benefits of the Enterprise Zone.

ELEMENTS OF A STABLE SOLUTION:


In considering this matter, the City Council should weigh the above issues and determine whether the Enterprise Zone is a tool that should be used to incentivize development and job creation in Sweet Home.

OPTIONS:

- 1. <u>Direct Staff to proceed with the process to re-designate the Sweet Home Enterprise</u> <u>Zone using the existing boundaries;</u> or
- 2. Direct Staff to proceed with the process to re-designate the Sweet Home Enterprise Zone and use the City limits as the Zone boundary; or
- 3. Do nothing and allow the Sweet Home Enterprise Zone to expire on June 30, 2018; or
- 4. <u>Other</u>

RECOMMENDATION:

Staff recommends Option #1: <u>Direct Staff to proceed with the process to re-designate the Sweet</u> <u>Home Enterprise Zone using the existing boundaries</u>. Based on the relatively low number of applications received under the Enterprise Zone to date, staff anticipates that including the areas outside of City limits would not require a significant amount of additional staff administrative time. Alternatively, it may be advisable to have a Linn County Enterprise Zone assume those properties since Planning and Building Permits are issued through Linn County.
