AN ORDINANCE VACATING PORTIONS OF THE PUBLIC RIGHT-OF-WAYS IDENTIFIED ON EVERGREEN LANE AND WEST PINE STREET, ALL WITHIN THE CITY OF SWEET HOME, LINN COUNTY, OREGON.

WHEREAS, the City Council has initiated the vacation proceedings on its own motion, and has had notice provided, as required by ORS Chapter 271; and,

WHEREAS, the Planning Commission was given an opportunity to review the proposed vacation and has made a recommendation to the City Council to approve the Vacation with amendments; and,

WHEREAS, no objections have been received to said proposed Vacation; and,

WHEREAS, no substantial effect to the market value of the property has been identified; and,

WHEREAS, the City Council has determined that no public interests will be prejudiced by the Vacation;

NOW, THEREFORE, THE CITY OF SWEET HOME DOES ORDAIN AS FOLLOWS:

Section 1. That the public right-of-ways in the City of Sweet Home, Linn County, Oregon, are vacated as depicted on the map titled Exhibit "A" and the descriptions of the vacated areas as set forth in Exhibits "B through L" attached hereto and by this reference incorporated herein.

Section 2. The City Recorder shall file with the County Recorder a certified copy of this ordinance, with copies also filed with the County Assessor and County Surveyor, as required by ORS Chapter 271.


