

ORDINANCE BILL NO. 2 FOR 1954

ORDINANCE NO. 278

IN THE MATTER OF STREET IMPROVEMENT DISTRICT
NO. 12 (SIDEWALKS) - for the improvement of
8th Avenue from the South boundary of K. Street
southerly along the West side of 8th Avenue
to the North boundary of D. Street; AND ALSO
for the improvement of K. Street from the West
boundary of 7th Avenue to the existing sidewalk
17 feet East of the Northwest corner of Lot 1,
Block 1, Parsons Addition along the South side
of K. Street.

WHEREAS it has been determined by the method provided by Ordinance No. 170, that the above described Street Improvement shall be made, and the proper assessments of the benefits therefor to the respective parcels of property abutting upon and/or to be benefited thereby as the case may be, have been determined; and

WHEREAS, the cost of said street improvement has been determined to be \$2,108.49 to be borne proportionately by the front footage of the property abutting thereon, and/or benefited thereby as the case may be;

NOW THEREFORE, THE CITY OF SWEET HOME DOES ORDAIN AS FOLLOWS:

Section 1. That an assessment for said street improvement is hereby levied upon the following described parcels of property of the owners or reputed owners, or persons having an interest therein in the amounts set opposite the descriptions of the respective parcels of property which said persons own or in which they have an interest, to-wit:


