ORDINANCE BILL NO. 1 FOR 1976 ORDINANCE NO. 656

AN ORDINANCE FIXING AND ESTABLISHING WATER SERVICE RATES AND AMENDING ORD-INANCE NO. 290

THE CITY OF SWEET HOME DOES ORDAIN:

Section 1. Section 5 and 6 of Ordinance No. 290 is hereby amended to read as follows:

The rates per 100 cubic feet of water to be charged for each bimonthly billing period hereafter billed are as follows:

Group 1: For single-family dwellings actually used for residential purposes. A single-family dwelling is limited to dwellings in which not more than two (2) people who are not members of the immediate family live as members of the family.

For 400 cubic feet or less, a minimum of \$4.50 For more than 400 cubic feet, \$4.50 plus \$.35 per 100 cubic feet for the next 100 cubic feet.

For more than 500 cubic feet, \$4.85 plus \$.65 per 100 cubic feet for the next 1000 cubic feet;

For more than 1,500 cubic feet, \$11.35 plus \$.33 per 100 cubic feet for the next 1,500 cubic feet.

The rate for all over 3,000 cubic feet shall be at \$.14 per 100 cubic feet, except during those billing periods ending in August and October when the irrigation rate is in force. The rate then for all over 2,800 cubic feet shall be \$.07 per 100 cubic feet.

Group II: For commercial and multi-family dwelling including two or more units serviced by one meter, the rates shall be:

For 400 cubic feet, or less, a minimum of \$6.50;

For more than 400 cubic feet, \$6.50 plus \$.72 per 100 cubic feet for the next 600 cubic feet;

For more than 1000 cubic feet, \$10.82 plus \$.58 per 100 cubic feet for the next 800 cubic feet;

For more than 1800 cubic feet, \$15.46 plus \$.43 per 100 cubic feet for the next 1000 cubic feet;

The rate for all over 2800 cubic feet shall be at \$.14 per 100 cubic feet.

For 1400 cubic feet, or less, a minimum of \$9.88;

For more than 1400 cubic feet, \$9.88 plus \$.60 per 100 cubic feet for the next 1200 cubic feet;

For more than 2600 cubic feet, \$17.08 plus \$.40 per 100 cubic feet for the next 47,400 cubic feet;

For more than 50,000 cubic feet, \$206.68 plus \$.30 per 100 cubic feet for the next 150,000 cubic feet;

For more than 200,000 cubic feet, \$656.68 plus \$.15 per 100 cubic feet for the next 300,000 cubic feet;

Over 500,000 cubic feet, \$1106.68 plus \$.10 per 100 cubic feet.

Group IV: For all Consumers outside the city limits, the rate charged shall be one and one-half times the rate charged to consumers in comparable groups within the city limits.

Section 6. Minimum monthly charge for service through meters larger than three-fourths (3/4) inch shall be at the rate of \$2.90 per inch diameter of the meter.

Section 2. AN EMERGENCY CLAUSE: It is hereby adjudged and declared that existing conditions are such that this ordinance is necessary for the immediate preservation of the public peace, health and safety. Therefore, an emergency is hereby declared to exist, and this ordinance shall take effect and be in full force and effect from and after its passage and approval by the Mayor.
