#### **RESOLUTION NO. 15 FOR 2016**

A RESOLUTION CONCERNING THE OREGON JAMBOREE, PARK CLOSURES, STREET CLOSURES AND RESTRICTIONS.

WHEREAS, on July 29, and July 30 and July 31, 2016, the Oregon Jamboree will hold a concert requiring street and park closures; and

WHEREAS, traffic patterns and parking issues need to be addressed to accommodate the events; and

WHEREAS, Sweet Home Municipal Code 10.04.030 provides that the City Council may, by resolution, establish or alter traffic and parking control;

WHEREAS, Sweet Home Municipal Code 12.12.010 and Sweet Home Charter Section 2 provide that the City Manager can limit park use.

NOW, THEREFORE, the City of Sweet Home does resolve as follows:

Traffic and park regulations shall be kept in effect as follows:

- A. From 7:00 a.m. on Friday, July 29<sup>th</sup> to 10 p.m. on Sunday, July 31<sup>st</sup>, 2016 18th Avenue from Long Street to Grape Street and 14<sup>th</sup> Ave from Kalmia Street to Hawthorne Street shall be closed and blocked off to through vehicular traffic at the direction of the Chief of Police or his designated representative; provided, residents living within the blocked off area, with no alternate routes, will be allowed ingress and egress.
- B. From 7: a.m. on Friday, July 29<sup>th</sup> to 10:00 p.m. on Sunday, July 31<sup>st</sup>, 2016, 18<sup>th</sup> Avenue/Ames Creek Road from Grape Street to Mountain View Road shall be closed and blocked off to through vehicular traffic at the direction of the Chief of Police or his designated representative and shall be designated as No Parking.
- C. From 11 a.m. on Thursday, July 28<sup>th</sup> to 10:00 p.m. on Sunday, July 31<sup>st</sup>, 2016, the portion of 18<sup>th</sup> Avenue immediately adjacent to the concert grounds and serving no residential properties, shall be completely blocked off to all vehicular traffic at the direction of the Chief of Police:
- D. From 5:00 p.m. on Thursday, July 28<sup>th</sup> to 10:00 p.m. on Sunday, July 31<sup>st</sup>, 2016, all areas of 18<sup>th</sup> Avenue between Long Street and the concert grounds shall be designated and signed as Disabled Parking Only and the Chief of Police is directed to enforce the provisions of ORS 811.615:
- E. From 6:00 a.m. on Monday, July 25<sup>th</sup> until 10:00 p.m. on Monday, August 1<sup>st</sup>, 2016, Sankey Park shall be closed to all persons except those authorized by the Oregon Jamboree or the Parks Director and

signage and fencing shall be in place to effect the safe closure;

- F. From 6:00 a.m. on Friday, July 29<sup>th</sup> until 10:00 p.m. on Sunday July 31<sup>st</sup>, 2016, waive SHMC 12.12.100 for Sankey Park only. SHMC 12.12.100 limits the sale, consumption, or possession of alcoholic beverages in.
- G. Appropriate and authorize fencing, signs, barricades or other markings which shall be installed by the Oregon Jamboree, at their own cost, to carry out the provisions of this resolution, and they shall become effective upon their installation pursuant to this resolution.

#### STATEMENT OF THE SUBJECT:

The Oregon Jamboree has presented a list of requests to the City in order to conduct the 2016 Oregon Jamboree. The requests are:

Complete closure of Sankey Park and Weddle Bridge from 6:00 AM on Monday, 1. July 25th, 2016 to 10:00 PM on Monday, August 1st, 2016. Partial closure of sections of 14<sup>th</sup> Ave from Kalmia St. to Grape St.

2.

- Partial closure of 18th Avenue from Long St. to Mountain View Rd. with 3. designation of portions of 18<sup>th</sup> Ave (between Long St. and concert grounds) as Disabled Parking Only and the designation of No Parking (on Ames Creek Rd. between Grape St. and Mountain View Rd.)
- 4. Waiver of Peddlers License requirements for all Oregon Jamboree vendors;
- 5. Waiver of water service, equipment and some employee service fees;
- Granting of Public Address System Permits; One for the Main Stage, another for 6. Sankey Park and a third for Thursday night only on 18<sup>th</sup> Avenue adjacent to Jamboree Grounds.
- Permission to use City property, including a portion of Sankey Park, for beer 7. gardens and recommended approval of Liquor License;
- Waiver of Event Fee as established under SHMC 5.04.010; 8.
- General assistance from the City. 9.
- Permission to allow semi-truck and equipment storage on City owned property at 10. the Public Works Environmental & Transportation Services Facility on 24<sup>th</sup> Avenue.

#### **RECOMMENDATION:**

- Approve Closure of Sankey Park to the general public from 6:00 AM on 1. Monday, 7-25-2016 to 10:00 PM on Monday 8-1-2016. This will facilitate erection of facilities within the park area, including fencing, sanitation facilities, vendor booths, etc. The Oregon Jamboree is required to fence and/or adequately sign all potential access points to the park "Park Closed - Authorized Personnel Only" (Requires Resolution). Waiver of the SHMC 12.12.100 Alcoholic Beverages in Sankey Park.
- Approve partial closure of 14th and 18th Avenues and designation of 2. temporary Disabled Parking areas on 18th Avenue. 18th Avenue adjacent to the Jamboree Grounds will be completely shut off to all vehicular traffic at approximately 11:00AM on Thursday, July 28th,

- 2016 at the direction of the Chief of Police or his designee. 18<sup>th</sup> Avenue/Ames Creek Road from Grape Street to Mountain View Road will be designated "No Parking". (Requires Resolution)
- 3. Approve waiver of Peddlers License requirement for any Oregon Jamboree vendor within OJ grounds.
- 4. Approve waiver of <u>outside</u> police manpower costs and PW equipment fees. Jamboree will be required to pay Public Works staffing fees if employees are required to respond after normal operating hours and or be placed on call or standby. Jamboree will also be required to utilize Public Works supplied hydrant meters where applicable and be liable for replacement costs should they become damaged or stolen.
- 5. Approve granting of Public Address Permit for Main Stage amplification beyond 1000', not to exceed midnight on Friday, 7-29-16 and Saturday, 7-30-16 and 11:30 PM on Sunday 7-31-16.
- 6. Approve granting of Public Address Permit for Sankey Park Stage amplification beyond 1000', not to exceed 11:30 PM on 7-29-16, 7-30-16 and 7-31-2016.
- 7. Approve granting of Public Address Permit for live bands and radio station amplification beyond 1000', on 18<sup>th</sup> Avenue immediately adjacent to the Jamboree Grounds, on Thursday night prior to the Jamboree. Amplification, not to exceed 8:00 PM on 7-30-15.
- 8. Grant permission to use on site city property, including a portion of Sankey Park for beer gardens.
- 9. Approve waiver of the \$50.00 per day event permit fee as required under SHMC 5:04:010 for the Jamboree as a whole. Fee requirements must still be met for individual vendors who may be subject under this code.
- 10. Approve City staff assistance with overall Jamboree goals and objectives, subject to budget constraints, Federal, State and local regulations.
- 11. Grant permission to allow semi-truck, and equipment storage on City owned property at the Public Works Environmental & Transportation Services Facility on 24<sup>th</sup> Avenue. All liability for theft or damages to this equipment to be borne by the OJ. OJ to be responsible for supplying own Padlock to be placed on identified gate access. OJ also to provide Public Works of estimated number of vehicles and/or equipment within three days of event start to ensure proper parking can be identified for use on-site.
- 12. Grant permission to use City portion of Event Center area. Known as Campground Site #9 and #10.

- 13. Approval of liquor license for the event. There are four "Beer Gardens" inside the Jamboree Grounds all located on City Property. Two of which are located within Sankey Park. Refer to map for specifics.
- 14. Suspend Sweet Home Municipal Code 9.20.030 Consumption or Possession of Alcoholic Beverages in Public Places during the time period of 12:00 PM on Thursday, 07-28-16 until 11:59 PM on Sunday, 07-31-16.

### **BACKGROUND ANALYSIS:**

This is the twenty-fourth annual Oregon Jamboree. Sankey Park will again be utilized by the event and will host two beer gardens, a second stage, a children's play area and various vendor booths.

The Jamboree is requesting that the park be closed to the public several days in advance. They have asked for park possession four day in advance of the event. A portion of 18<sup>th</sup> Ave will again be blocked off 24 hours a day during the event to protect concert patrons.

The Police Department will maintain staffing during the event. Officers will be on foot, in vehicles and on bikes covering not only the Jamboree Grounds but also the nearby surrounding campgrounds. The jamboree will continue to augment police staffing using DPSST certified private security personnel to deal with unruly patrons.

The Oregon Jamboree also has 23 camp sites of varying sizes throughout the City. There are roughly 2648 camp sites that are rented out throughout the weekend.

The daily attendance is typically estimated at between 11,000 to 15,000 people.

The enforcement and security effort of SHPD is augmented with assistance from the Linn County Sheriff's Office, the Lebanon Police Department and the Oregon State Police.

## FISCAL IMPACT:

This event has substantial impact on several City agencies. Funds spent in support of this event may impact our ability to provide general services to the City later in the year, should an emergency arise. Conversely, the event has a powerful and positive impact on the community as a whole and the City's support of the event is warranted.

#### **ALTERNATIVE:**

Grant some or none of the requests made by The Oregon Jamboree.
