RESOLUTION No. 10 FOR 2004

A RESOLUTION TO SET RACQUETBALL/HANDBALL COURT FEES.

WHEREAS, the City Council deems it desirable to establish charges which are reflective of actual operating costs for use of the Racquetball/Handball Court.

NOW THEREFORE, the City Council resolves that the following rates are hereby established and made effective immediately:

Annual Membership Rates

Employee Employee Family	\$0 \$25.00	

\$6.00 non-refundable cost for the card lock key for access to the Court.

If items are not covered in this resolution, the City Manager is authorized to set a temporary fee until it can be approved by City Council.

It has been determined that this rate is classified as not being subject to Oregon Constitution Article XI, Section 11 (b) Limitations.

This Resolution shall be effective immediately upon its passage.

City of Sweet Home Handball and Racquetball Association Membership Information and Facility Use Rules and Regulations

1) Court Use Procedure

- a) Lock combinations or cards will be changed as needed. If security and rules continue to be breached, we either close the court, change the lock system, increase rates or any combination of the above.
- b) Reservations may be made one week in advance by signing up at the court. Defacing or destroying the weekly list will result in padlocking the door for the remainder of that week.
- c) The person who used the court must fill out the log sheet indicating his/her name, membership card number and number in party. You are responsible for your party members' conduct.
- d) The time limit for use of the court for a single group of up to four (4) people is one (1) hour.
- e) Refer all questions or problems needing immediate attention to the Park Caretaker. You may also contact the Public Works Department during business hours, Monday through Friday, 9:00 a.m. to 5:00 p.m., at 367-5128.

2) Court Availability

- a) Each member is limited to one reservation per day.
- b) "Prime time" is 3:00 p.m. to 10:00 p.m., Monday through Saturday. The rest of the week hours and all day Sunday are non-prime hours.
- c) An individual may reserve the court only once a week during the same prime time hours.
- d) An individual may have priority to actually play (whether or not he/she reserved the court) only twice a week during prime time hours.
- e) You may not make a second reservation in a two-day period if you have not used the first reservation.
- f) Reserving the court for the same time block on consecutive days is not allowed, skip a day in between.

3) Court Policy

- a) Please do not bring bicycles or other sports equipment into the court. If anything else is used, membership will be forfeited and a citation and fine may be issued.
- b) Please use your reservations! No shows leave the court idle when others may want it. Your reservation will be held for ten (10) minutes only. If you are not there someone else will be allowed to use the court.

c) Please do your part in keeping the court clean. In order to help keep membership fees from steadily increasing, please keep the court clean. Spiting, urinating, defecating and other uncivilized behavior in the building will result in immediate membership termination, and other civil fines and penalties as may be applicable including court closure.

4) Membership Guidelines

a) Membership cards may be purchased at City Hall, Monday through Friday, 9:00 a.m. to 5:00 p.m.

b) Annual Membership Rates	Resident	Non-Resident

* \$6.00 cardlock key cost not included in membership rates. A \$6.00 non-refundable cost will be charge for each cardlock key issued. Cardlock keys may not be loaned out.

Note: A "resident" is defined as a person whose place of residence or business lies within the Sweet Home City limits.

- c) Membership privileges and responsibilities:
 - (1) Use of the court for one year
 - (2) Limit is one (1) reserved court use per day.
 - (3) Membership expires one year from the date membership fee is paid.
- d) Memberships are only issued to persons age 16 or over. Persons under 16 may not have his/her name on a family card. They are welcome to play, but must be accompanied by some one 16 or older.
- e) Each membership may be used only once per day. A single membership number may appear on the log only once a day.
- f) There is a \$6.00 non-refundable charge for re-issuance of any lost or damaged card.
- g) Alcoholic beverages, smoking, tobacco or drugs are not allowed in the building. Violation will result in loss of membership and facility use.
- h) City employees wishing to use the court must register in advance. A cardlock key will be available to check out during the normal business hours. Any employee wishing to use the court on weekdays after 3:00 p.m. or on weekend or holidays must purchase an individual cardlock key for \$6.00. These cards may not be loaned out and are subject to replacement fees if lost or damaged. City employees are subject to all the provisions of the Membership Information, Facility Use Rules and Regulations.
