RESOLUTION NO. 11 FOR 2006

A RESOLUTION TO DECLARE AND MAINTAIN CITY OWNED PROPERTY LOCATED AT 13S1E32CC/5800 AS A WETLAND MITIGATION SITE.

WHEREAS, the City of Sweet Home, an Oregon Municipal Corporation, is the owner of real property known as Tract B of Carla Place II, in the City of Sweet Home, Linn County, Oregon, (Assessor Map Page 13S1E32CC Tax Lot 5800) referred to herein as Property; and

WHEREAS, the Property has a warranty deed restriction for public park purposes when it was granted to the City of Sweet Home on April 7, 1994; and

WHEREAS, the City of Sweet Home reserves the right to place an accessible pathway of organic material for access or viewing of the Property in a method, manner and location to minimize any impact to plant vegetation; and

WHEREAS, the Property is referenced in Division of State Lands Enforcement File #4790; and

WHEREAS, the Division of State Lands requires that a covenant be declared on the Property; and

WHEREAS, the attached declaration is to limit and restrict the use to which the Property may be put, and specifying that the declaration shall constitute a covenant running with the land and that it shall be binding on all persons; and

WHEREAS, the restriction is for the benefit of and limitations upon all future owners of the Property and the State of Oregon to protect the Property from use inconsistent with, or contrary to, the restriction; and

WHEREAS, the restriction shall be perpetual and never ending, except upon the contemporaneous consent and revocation by the Property owner, the State of Oregon and the United States Army Corps of Engineers; and

THE CITY OF SWEET HOME DOES RESOLVE AS FOLLOWS:

The Property shall be used as a Wetland Mitigation Site with conditions as noted on the attached Declaration of Restrictive Covenant, Exhibit A and map, Exhibit B.

THIS resolution shall be effective immediately upon its passage.



DECLARATION OF RESTRICTIVE COVENANT.

The City of Sweet Home, an Oregon Municipal Corporation, is the owner of real property known as Tract B of Carla Place II, in the City of Sweet Home, Linn County, Oregon (Assessor Map Page 13S1E32CC Tax Lot 5800), granted to the City for public park purposes, referred to herein as Property, hereby makes the following declaration to limit and restrict the use to which the Property may be put, and specifying that the declaration shall constitute a covenant running with the land and that it shall be binding on all persons.

PURPOSE OF RESTRICTIONS

The restriction is for the benefit of and limitations upon all future owners of the Property and the State of Oregon to protect the Property from use inconsistent with, or contrary to, the restriction.

DURATION OF USE

The restriction shall be perpetual and never ending, except upon the contemporaneous consent and revocation by the Property owner, the State of Oregon and the United States Army Corps of Engineers.

RESTRICTIVE USE

The Property shall be used as a Wetland Mitigation Site. The Wetland Mitigation Site shall be maintained in its natural condition to attract wildlife, including waterfowl, and used exclusively as a wetland. No building, structure, or improvement shall be erected, constructed, or placed within the Wetland Mitigation Site. Native or planted vegetation shall not be removed without the written permission of the Oregon Division of State Lands. Livestock, including horses, shall be kept out of the Wetland Mitigation Site. See Division of State Lands Enforcement File # 4790.

The City of Sweet Home reserves the right to place an accessible pathway of organic material for access or viewing of the Property in a method, manner and location to minimize any impact to plant vegetation.
