RULES & RESERVATIONS

Failure to abide by these rules, regulations and policies shall be grounds for termination of membership. Rules, regulations and policies may be changed or altered from time to time; all such changes or alterations shall be posted in the court. Until changed the following rules, regulations and policies shall be in effect.

- Court hours are from 6am until 10pm
- All participants must have a current membership
- All children under the age of 18 must be accompanied by an adult
- Shirts and shoes are required
- All injuries must be reported
- Food, drink, gum, tobacco, and other such items are not permitted on the court
- Avoid striking the court walls with racquets.
- Bicycles, skateboards, etc., are NOT allowed
- The court is open on a first come first serve basis, unless the court is reserved
- Reservations can be made for one hour
- The court may be kept longer if a reservation has not been made for the court for the time slot following
- If the court is not claimed within 10 minutes of reservation time, it becomes available to others
